MINUTES OF THE MEETING OF WINNERSH PARISH COUNCIL HELD AT 7.45 p.m. ON TUESDAY 10 MARCH 2009 IN THE JOHN GROBLER ROOM

1 APOLOGIES

- **1.2 Apologies for lateness** none
- 1.3 Cllr Southgate welcomed WBC Cllr Malcolm Storry, who was here to observe the meeting. Cllr Storry spoke briefly about his role as 'the friendly face of the Standards Committee'.
- 2 MINUTES OF THE PREVIOUS MEETING
- 2.1 The minutes of the Council meeting of 10 February 2009 were agreed, and the Parish Council **RESOLVED** to sign the minutes as a true record.

- **3.1** Cllr Hunt had nothing to report yet about Community Service volunteers.

3.2 Rainbow Centre Building Works

Cllr Siggery reported that a paper is to go to WBC Executive next week regarding Phase 3 of the Children's Centres project. Cllr Bray said that it was the money for Phase 1 of the Rainbow Centre improvements that is in question. WPC's immediate concern is with this 'Phase 1'. Cllr Siggery will inform Cllr Southgate as soon as she has clarification.

7 BOROUGH COUNCIL MATTERS

7.1 Cllr Siggery reported that the wooden bollards in Sherwood Road will be taken out and replaced by something more suitable.

A review into the small overlap in the catchment areas of Winnersh and Bearwood Primary Schools is being completed. It is not a controversial change.

7.2 Cllr Bray confirmed the rise in the WBC council tax as 4.79%. Tenant Services have issued a letter confirming the rent increase of 6.2%. This has since been changed by Central Government to 3.1%. Tenants will have to pay the 6.2% figure until the change over to the revised figure can be implemented.

The traffic lights at the Reading Road Post Office are being upgraded and will be back in operation soon.

The Core Strategy review begins next week. Cllr Bray will speak about the North Wokingham SDL, which affects Winnersh.

The Forest School U14 football team has reached a cup final to be played at Old Trafford. The Forest School is to undergo an Ofsted inspection soon.

9 LAST PLANNING COMMITTEE MEETING

- **9.1** The minutes of the meeting of 17 February 2009 were agreed, and the Parish Council **RESOLVED** to sign them as a true record.
- **9.2** Cllr Grimson reported on the meetings of 17 February and 9 March 2009. There was very little planning activity to report.

10 LAST R&A COMMITTEE MEETING

- 10.1 The minutes of the meeting of 3 March 2009 were agreed and the Parish Council **RESOLVED** to sign them as a true record.
- 10.2 Cllr Plant reported that Friday 11 December 2009 had been agreed as the date for the next Christmas Lights event. The two Primary Schools and the mayor were booked for the event.
- 10.3 Cllr Plant has leaflets showing some of the proposed equipment for the Adult 'Outdoor Gym'. She is surveying local opinion regarding the proposals in preparation for making a report to WBC. Proposed funding for the project is 50% WPC and 50% WBC S106 money.
- 10.4 The Clerk is contacting Sainsbury's and local organisations regarding the WBC Litter Pick on Sunday 26 April 2009.

10.5 Cllr Southgate presented the full details of a recommendation to Full Council for the replacement of the Community Hall security lighting. The Council **RESOLVED** to accept Binfield Electronics' quotation (see Correspondence N5), this to include Option 2 for low-energy lighting. **ACTION: Clerk**

11 LAUNCH OF THE PARISH WEBSITE AND WPC STRATEGIC AIMS DOCUMENT

11.1 Cllr Southgate will formally launch the new website tomorrow. A press release will be issued. A contribution by the Winnersh Historical Society will be added to the website later.

The Council **COMMENDED** the website and thanked Cllr Southgate for all the work he had put in preparing it.

11.2 The WPC Strategic Aims document will be made available on the website. It was suggested that the Wokingham Times be asked to publish a link to the website in its 'Winnersh' section on local events.

13 PARISH AND TOWN COUNCILS CHARTER

13.1 Cllr Southgate reported that WPC had approved the draft charter in June 2008. He presented the final version, which included a paragraph on procedures for reviewing the Charter.

The Council **RESOLVED** to adopt the Wokingham Borough Parish and Town Councils Charter.

The Clerk will write to WBC confirming this. ACTION: Clerk

14 REPRESENTATIVES ON OUTSIDE BODIES

- 14.1 Cllr Grimson attended a BALC Executive meeting. A County Training Partnership is to be started. He will attend a Planning training course in April 2009.
- 14.2 Cllrs Southgate, Peffers and Cooke attended a NAG meeting on 23 February. The Battle of the Bands first and second rounds have taken place. They received good press coverage. The third round is on 27 March.

Cllr Southgate reported on the NAG application for Lottery funding for the Winnersh Meadows project. He had attended a meeting with NAG, WBC and Lottery representatives on 25 February. A £50,000 Lottery grant has been applied for. Further funding will be provided by WBC (section 106 monies) and WPC.

15 APPROVAL OF THE MARCH ACCOUNTS FOR PAYMENT

- 15.1 Cllr Wilkins explained that the Knockout Entertainments invoice is a deposit for equipment for the fete.
- **15.2** The Council **RESOLVED** to approve Cllr Grimson's attendance on the BALC Planning training course.
- 15.3 The Council **RESOLVED** to approve the final salary increase of 2.75% for 2008/9. This is an increase of 0.3% above the provisional figure already implemented. This increase will be backdated to April 2008 and will be included in the April 2009 payroll run.
