MINUTES OF THE ANNUAL MEETING OF WINNERSH PARISH COUNCIL HELD AT 8.40 p.m. ON TUESDAY 12 MAY 2009 IN THE JOHN GROBLER ROOM

1 ELECTION OF CHAIRMAN FOR COMING YEAR

1.1 Cllr Wilkins took the chair. Cllr Armstrong **PROPOSED** and Cllr Cooke **SECONDED** Cllr Southgate as Chairman for the forthcoming year and this was **RESOLVED.** Cllr Southgate took the Chair.

2 ELECTION OF VICE-CHAIRMAN

2.1 Cllr Armstrong **PROPOSED** and Cllr Wakefield **SECONDED** Cllr Wilkins as Vice-Chairman and this was **RESOLVED**.

3 DECLARATION OF ACCEPTANCE OF OFFICE

3.1 Cllrs Southgate and Wilkins signed the Declaration of Acceptance of Office forms.

5 APPOINTMENT OF COUNCILLORS TO COMMITTEES

- **5.1** Councillors were **PROPOSED** to serve on the Committees from the Chair and were **RESOLVED** as follows:
- **5.1.1** Recreation and Amenities Committee: Cllrs Cooke, Peffers, Plant and Wakefield. Cllrs Southgate and Wilkins ex officio.
- **5.1.2** Planning Committee: Cllrs Grimson, Hunt, Jupp and Plant. Cllrs Southgate and Wilkins ex officio.
- **5.1.3** Finance and General Purposes Committee: Cllrs Armstrong, Bray, Clark, Hunt and Siggery. Cllrs Southgate and Wilkins ex officio.

5.2 Appointment of Committee Chairmen

Cllr Wilkins **PROPOSED** and Cllr Peffers **SECONDED** Cllr Plant as R&A Committee Chairman for the forthcoming year and this was **RESOLVED**.

Cllr Plant **PROPOSED** and Cllr Hunt **SECONDED** Cllr Grimson as Planning Committee Chairman for the forthcoming year and this was **RESOLVED**.

Cllr Bray **PROPOSED** and Cllr Armstrong **SECONDED** Cllr Clark as F&GP Committee Chairman for the forthcoming year and this was **RESOLVED**.

Thus, as per Standing Orders, the Executive Committee will be Cllrs Southgate, Wilkins, Clark, Grimson and Plant.

5.3 Councillors were reminded that they had to ensure that their Councillors' Register of Interest forms were up to date. The current Register of Interest forms and Revision Forms are available from the Clerk.

7 NEW CHAIRMAN'S STATEMENT

7.1 Cllr Southgate had already made an address that evening to the Annual Parish Meeting (see APM minutes). He thanked the councillors for their vote of confidence in re-electing him as Chairman for another year. A lot of work had been done over the previous year and the Council now needs to focus on its direction for the future. The Strategic Aims document will be formally adopted at the next Full Council meeting and this will be an opportunity for the Council to discuss the steps necessary to implement the Aims.

10 MINUTES OF THE PREVIOUS MEETING

10.1 The minutes of the meeting held on 14 April 2009 were **AGREED**, with the minor change that at 14.1 "Cllr Grimson" should read "Cllr Cooke", and the Parish Council **RESOLVED** to sign them as a true record.

11 MATTERS ARISING

11.1 Cllr Cooke distributed some leaflets clarifying the WBC recycling scheme.

12 PUBLIC SESSION

12.1 No questions were forthcoming.

13 COMPLAINTS/FAULT TRACKING

13.1 The Clerk reported the WRFC evening parking problem had been resolved – at least for the time being.

14 CORRESPONDENCE

14.1 Item N6; Cllr Southgate reported that the Swine Flu leaflet gives basically the same information as has been seen in the news.

15 REPORT OF THE LAST R&A COMMITTEE MEETING

15.1 The minutes of the meeting of 5 May 2009 were agreed and the Parish Council **RESOLVED** to sign them as a true record.

- **15.2** Cllr Plant reported that a response was awaited from Wendy Crosson-Smith regarding the installation of the Adult Exercise Equipment. The idea of having the equipment is to provide equipment for the full age range at Bearwood Recreation Ground. Forest School has offered to help with the initial training on the equipment once it is installed.
- **15.3** The Clerk gave an update on the roof trusses in the Main Hall. Preliminary investigations suggest that repairs will need to be done to the gable ends to repair dry rot. Further investigations into the truss problems can be made at that time, after which it will be possible to assess the extent of the repairs, if any, needed on the roof trusses.

16 REPORT OF THE LAST PLANNING MEETING

- **16.1** The minutes of the meeting of 21 April 2009 were agreed and the Parish Council **RESOLVED** to sign them as a true record.
- 16.2 Cllr Jupp reported that the Committee had considered Keith Baker's request for 3 items to be put on a Highways 'wish-list'. The restrictions on the wishlist are that only S106 requests can be considered and that consequently Highways maintenance items cannot be included. Therefore the requests from last year for pavement repairs and flood management repairs are not eligible. The Planning Committee will have a further look at the speed humps on Churchill Drive. The Council **RESOLVED** to put forward the following items as its wish-list:

1) re- positioning of the island at the crossroads which prevents lorries from turning right safely into King Street Lane.

2) provision of signage to prevent cars from turning left into Sainsbury's on King Street Lane

The Clerk was also asked to write to Cllr Baker requesting that the Reading Road pavements be resurfaced as this was stated to have just missed being included in the 2008/9 Highways Maintenance programme. **ACTION: Clerk**

PCSO Nellie Williams reported that she will pass comments made on the dangerous driving seen at the crossroads to the Roads Policing Department and will feed back the response to PCSO Alistair Marman.

16.3 Mrs Dodsworth asked whether the electronic speed flash can be reinstated on Arbor Lane. One option would be for the Parish Council to pay for the hire of the equipment. The Clerk will investigate the details. ACTION: Clerk

17 REPORT OF THE EXECUTIVE COMMITTEE MEETING

- **17.1** The minutes of the meeting of 21 April 2009 were agreed and the Parish Council **RESOLVED** to sign them as a true record.
- **17.2** Cllr Southgate reported that the Executive Committee had chosen the Civic Award winner for 2009.

18 WINNERSH VILLAGE FETE

18.1 Cllr Wilkins reported the next Fete meeting will be on Wednesday 13 May 2009. Geoff Harper is organising the arena. There are about 20 stalls confirmed at the moment. The competition details are being sent out to the primary schools. Publicity is being arranged for the Wokingham Times and Winnersh Matters

19 REPRESENTATIVES ON OUTSIDE BODIES

19.1 Cllrs Cooke, Peffers and Southgate had attended a NAG meeting on 30th April. The Battle of the Bands had been very successful and made £3000 of which £2000 will go to set up a Business Enterprise Club at Forest School. The NAG's next event will be a Scavenger Hunt at the end of August.
