MINUTES OF THE MEETING OF WINNERSH PARISH COUNCIL HELD AT 7.45 p.m. ON TUESDAY 8 SEPTEMBER 2009 IN THE JOHN GROBLER ROOM

PRESENT: Cllrs J Southgate (Chairman), M Armstrong, P Bray, W Clark,

In attendance: Clive Hudson (WPC Clerk), plus 2 members of the public.

1 APOLOGIES

1.1 Apologies for absence – Cllrs E Cooke, E Siggery, J Wilkins.

2 ALLOTMENT COMPETITION AWARDS 2009

2.1 Cllr Southgate reported that the overall standard of the allotments had improved yet again. Only 15 marks had separated the top 5 allotments and a re-mark had been necessary to separate the winners. There is a long waiting list for allotments and the Council is trying to ensure that allotment holders tend their plots properly – use it or lose it!

Cllr Southgate presented the prizes to:

2nd Mr J Dyke

Mrs C Purcell and Mr D Nelms were 3rd= but were unable to be at the meeting to receive their prizes.

3 MINUTES OF THE PREVIOUS MEETING

3.2 The minutes of the Council meeting of 14 July 2009 were agreed, and the Parish Council **RESOLVED** to sign the minutes as a true record.

4 MATTERS ARISING

4.1 The Clerk summarised WBC's response regarding the accident figures and provision of traffic lights on Mill Lane. The Council noted that the repair works to the road and bridges on Mill Lane had been completed on schedule over the summer holidays and commended WBC on this work.

5 PUBLIC SESSION

5.1 None

6 COMPLAINTS AND FAULT TRACKING

6.1 The Clerk reported on three complaints over the summer:

6.1.1 Week commencing 3 August:

An incident was reported of a child being cut by broken glass on the hardcore basketball pitch. The Caretaker and Clerk both removed glass in the vicinity. A day later another incidence of broken glass was reported and the glass was cleared away. The Clerk has spoken to PCSO Nellie Williams and James Newman to make them aware of the problem. No further incidents of broken glass have been reported near the basketball pitch.

6.1.2 27 August 2009:

Notification was received of an incident on the Recreation Ground involving a member of the public and the Caretaker's dog. The police have dealt with the matter as a private issue. The Caretaker's family has sealed off the gate and secured the fencing between the caretaker's garden and the Community Hall. The Clerk has written to the member of the public involved.

6.1.3 3 September 2009:

A phone call was received from a member of the public regarding oil on the Devil's Island Swing. The Clerk has checked the equipment thoroughly over several days and no trace of oil can be found on the equipment. The equipment is now closed pending the replacement of several loose screws.

7 CORRESPONDENCE

7.1 Correspondence received prior to the issue of the agenda

Item 28; The Council agreed that the Adult Gym should be put forward to the Town and Parish Working Group as an example of a successful project.

Cllr Southgate distributed press cuttings of the Adult Gym for councillors to view.

Item 30; Cllr Southgate confirmed that the TVP Winnersh Neighbourhood Update is available on the TVP website.

Item 54; Cllr Southgate summarised Keith Baker's update on the progress of the items on WPC's highways wish-list for 2009/10.

7.2 Correspondence received since the issue of the agenda

Item N6; The Council considered the NAG Consultation document and asked Cllr Southgate to respond on its behalf.

Item N7; The Council noted the Core Strategy exhibition details and the residents meeting on 22 September regarding the Northern Link Road.

Item N13; The Council noted the withdrawal of the plans for 10 Targett Court.

8 BOROUGH COUNCIL MATTERS

- 8.1 Cllr Armstrong reported his concerns regarding the number of cars being displayed as 'for sale' along the Reading Road. He also expressed concern over the general untidiness caused by litter and overgrown hedgerows. He reported that there was a small group of NEET youngsters in the area who had a potential for mischief. He is going to discuss this with the WBC Health Select Committee.
- 8.2 Cllr Bray reported that Andy Couldrick has started as head of WBC Children's Services. A new Head of Business Development has been appointed. Cllr Bray is due to meet with Keith Baker regarding ongoing concerns with parking problems on Danywern Drive. She is also due to attend a meeting regarding anti-social behaviour in the Dunstan Drive area. Cllr Bray confirmed that some tickets had been issued for anti-social parking in Cavendish Gardens.

9 PARISH COUNCILLORS' QUESTIONS

9.1 None.

10 LAST PLANNING COMMITTEE MEETING

- **10.1** The minutes of the meetings of 13 July, 4 August and 25 August 2009 were agreed, and the Parish Council **RESOLVED** to sign them as a true record.
- 10.2 Cllr Grimson reported on the meetings of 13 July, 4 August and 25 August 2009: Cllr Grimson reported that the plans for a 16 bed dementia care unit at Lord Harris Court had been passed. Lord Harris Court was in consultation with WBC regarding dropped-kerbs on Mole Road. The development at Old Oak, Mole Road, has gone to appeal. Cllr Grimson reported that there had been a few enforcement issues, including the development near Winnersh Garden Centre which was confirmed as being subject to plans approved in 2006.
- 10.3 The Council noted that development of the plot adjacent to Baslow Road had started. Cllr Bray reported that there was a query regarding whether the size of some of the rooms was suitable for buildings designated as social housing.

11 LAST R&A COMMITTEE MEETING

- 11.1 The minutes of the meeting of 1 September 2009 were agreed and the Parish Council **RESOLVED** to sign them as a true record.
- 11.2 Cllr Plant reported that the Adult Exercise equipment was installed and opened over the summer. The Council thanked the members of the Committee for their hard work, particularly Cllr Cooke for highlighting the idea, Cllr Wakefield for championing the project and Cllr Plant for gathering support from potential users.
- 11.3 Lord Harris Court have requested that some of their residents be allowed to use the pool table at certain times. AVC have agreed to this. The Committee is considering installing dropped-kerbs and pavements on Mole Road to improve access for the Lord Harris Court residents to the Community Centre and Adult Gym. The TVP had a Fun Day on 27 August which was well attended.
- 11.4 The Committee has considered a report on the hall floor and is proposing work next year to sand the floor back to bare wood and re-seal.
- 11.5 The Committee is being stricter with allotment tenants who do not keep their plots cultivated. This will include the termination of tenancies if necessary.

12 LAST FINANCE & GENERAL PURPOSES COMMITTEE MEETING

- **12.1** The minutes of the meeting of 28 July 2009 were agreed, and the Parish Council **RESOLVED** to sign them as a true record.
- 12.2 Cllr Southgate reported that there were some actions relating to the Internal Audit and these were ongoing.
- 12.3 Cllr Armstrong reported that the autumn edition of Winnersh Matters would be ready for press around the end of September. It would be in a six-page format. Several requests have been received to publish adverts and this will be considered.
- **12.4** The Council **RESOLVED** to accept the accounts for the quarter ending 30 June 2009.

13 EXTERNAL AUDITOR'S REPORT

13.1 Cllr Southgate read the external auditor's comments on the audit of 2008/9. He thanked the FAO and Clerk for the extra work they had put in to prepare an Intermediate Audit. The Clerk will display on the notice boards the notification of the right to view the external auditor's report.

14 COMMUNITY HALL ROOF REPAIRS

- 14.1 The Clerk reported that the structural engineer's instructions had been sent to the builders as the basis for their tenders. Cllr Hunt queried whether this would be a good time to renew the insulation in the hall. Cllr Southgate observed that the priority must be to get the necessary repair work carried out as soon as possible. The Executive Committee will review the quotations for the repairs, as authorised at the July 2009 Full Council meeting.
- 14.2 The Council discussed an outline report from Binfield Electrical regarding work proposed to the Community Centre electrics. The Council **RESOLVED** to authorise up to £3000 for these repairs, to be taken from the Contingency budget, and requested a full breakdown of the works and costs from the contractor.

15 WINNERSH FETE 2009

- 15.1 Cllr Southgate reported that the finances of the fete had been reviewed by the F&GP Committee. The Council still needed to decide on the distribution of the proceeds of the raffle and concessions. After discussion it was proposed and the Council **RESOLVED** to give £100 to each of the following organisations:
 - 1) Wokingham ATC
 - 2) The Thames Valley and Chiltern Air Ambulance Trust
 - 3) SCOPE (the WBC Mayor's Charity)

16 REPRESENTATIVES ON OUTSIDE BODIES

- 16.1 Cllr Peffers reported on the NAG Scavenger Hunt at Dinton Pastures. This had made a modest profit and it was hoped to run the event again next year. He and Cllrs Southgate, Cooke and Bray had attended a NAG meeting on 15 July.
- Cllr Plant reported that there had not been a meeting of the Wokingham Youth Committee for at least a year. The Clerk will contact WBC's Nigel Shaw (cc Rob Stanton, Executive Member) to see whether this group is still running.

- 16.4 Cllr Southgate had attended the CAB AGM on 31 July. The CAB is particularly active coping with the problems associated with recession and family break-up.
