# MINUTES OF THE ANNUAL MEETING OF WINNERSH PARISH COUNCIL HELD AT 8.30 p.m. ON TUESDAY 11 MAY 2010 IN THE JOHN GROBLER ROOM

#### 1 ELECTION OF CHAIRMAN FOR COMING YEAR

1.1 Cllr Plant PROPOSED and Cllr Peffers SECONDED Cllr Wakefield as Chairman for the forthcoming year and this was RESOLVED. Cllr Wakefield took the Chair.

A one-minute silence was observed in memory of Cllr Judith Wilkins.

Cllr Armstrong **PROPOSED** and Cllr Bray **SECONDED** Cllr Southgate as F&GP Committee Chairman for the forthcoming year and this was **RESOLVED.** 

Thus, as per Standing Orders, the Executive Committee will be Cllrs Wakefield, Southgate, Grimson and Plant.

## 7 NEW CHAIRMAN'S STATEMENT

7.1 Cllr Wakefield reported that Cllr Southgate had already given an extensive report at the Annual Parish Meeting earlier that evening.

This is a time of enormous change in the momentum of the Council. The Council is attempting to involve more of Winnersh in community activities. Winnersh Matters is establishing itself as a means of communication. Public interest is to be encouraged and the public is invited to come to meetings or speak to councillors individually.

#### 8 WINNERSH FUEL ALLOTMENT TRUST

8.1 The meeting **RESOLVED** to confirm the nominated trustees as Cllrs Bray and Southgate

Cllr Bray reported that trustees remain unchanged except that a replacement is required for Cllr Clark. Ideally another trustee is required from the Parish Council to replace him.

- **9.2.3** WBC Waste Management Committee Cllr Cooke
- **9.2.4** Wokingham and Winnersh Youth Committee Cllr Plant It was noted that this organisation has not met in the previous year.

The Council asked the Clerk to write to SW Trains expressing its concern and asking for a ticket machine to be installed or for free travel to be granted to the residents of Winnersh.

(Earley) had been refused. WBC are receiving comments about its Bus Stop and Gateway policy. The visit to the J11 wind turbine is on Monday 17 May. Councillors and guests are invited. The Council asked the Clerk to invite councillors from Arborfield & Newnham and Shinfield parishes to join them on the visit.

The Council confirmed that HARM will be invited to speak about windfarms once an application for the windfarm in Arborfield has been received. Peter Stuart, WBC Resilience Manager, spoke to the meeting on 10 May. He has sent guidelines for an Emergency Parish Plan.
