## 7 BOROUGH COUNCIL MATTERS

## **7.1** Cllr Armstrong reported that:

- 1) There is no WBC Council meeting this month.
- 2) Charities, for example CAB and Children's Society, face significant funding cuts and are struggling to maintain services to the vulnerable, eg 'Places of Safety'.

## **7.2** Cllr Bray reported that:

- 1) Work is ready to start on the development of the cricket ground at Sadler's End.
- 2) A decision is awaited from WBC Highways regarding the redevelopment of the highway on Poplar Lane.
- 3) A decision is awaited from WBC Highways regarding the access route to the proposed development on Arbor Lane.
- 4) A decision on the development at 212 Bearwood Road has been deferred and has not been listed yet.
- 5) The PCSOs are proposing to enforce the parking restrictions on Cavendish Gardens.
- 6) Re-signing and tarmacing of the cycle route on Reading Road is due to take place, using S106 money.
- 7) The Comprehensive Service Review will consider the ongoing flood mitigation for the Hatch Farm Dairies site.
- 8) Motor Cycle parking will considered in the next Parking Strategy document in the new year.
- 9) A WBC leaflet 'Don't Waste Our Future' has been distributed. It gives guidelines on the proposed changes to waste collection to take effect from April 2012.
- 10) The Comprehensive Spending Review of 20 October may include changes to the housing subsidy system.
- 11) Transformation:

hot-desking is to be taken up by the Planning Department; staff and councillors will soon be paying for parking at Shute End

Cllr Siggery reported that Wokingham Direct is part of the hub for transformation service and that more services are due to come in to the service.

**9.3** Cllr Grimson reported that the Planning Committee may go over budget for tree husbandry if further work is required on the Pine Tree or as a result of the forthcoming big tree survey.

- 10.2 Cllr Plant reported on a recommendation from the R&A Committee to go ahead with the replacement of the strip lights in the main hall with low-energy equivalents. The Council **RESOLVED** to accept the recommendation from the R&A Committee to instal low-energy strip lights in the Community Centre.
- 10.3 Cllr Plant reported that Winnersh Primary School will be unable to attend the Christmas Lights event. The event will still take place with a choir from Bearwood Primary School.

Cllr Armstrong will train up a team to set up the lights.

Cllr Armstrong will write to Slough Estates to request a donation to buy lights.

- 12.2 Cllr Armstrong reported on discussions regarding the best utilisation of the bar and the adjoining room. These broadened out into 3 main topics:
  - 1) the business relationship between the Council and the franchisee
  - 2) the best use of the Council buildings for offices and private functions
  - 3) the marketing of the facilities.

Cllr Armstrong recommended that the long term use of the Council's rooms should be considered by the R&A Committee and that the F&GP Committee should consider funding the FAO to make a marketing report on the Council's buildings.

12.3 Cllr Armstrong recommended that Cllr Wakefield decides who should sign the contract.
