  - 1) The management of the Acorn Centre are happy to discuss with R&A members their vision for the use of Community Centres. (a copy of N9 of Correspondence was given to each councillor.)
  - Cllr Wakefield encouraged the Council to work together with other local community organisations.

**8.1** Cllr Armstrong gave further details regarding the funding and workings of the Acorn Centre at Woosehill.

## 9 LAST PLANNING COMMITTEE MEETING

- **9.1** The minutes of the meeting of 16 February 2011 were agreed, and the Parish Council **RESOLVED** to sign them as a true record.
  - Cllr Grimson reported that the Committee had objected to the siting of the proposed telephone mast near Sainsbury's.
- 9.2 Cllr Grimson reported on the Recommendation from the Planning Committee to have the Priority 1 tree work done as soon as possible. The Parish Council **RESOLVED** to use the remaining funds from the Planning Tree Husbandry and Miscellaneous budgets and £500 from the F&GP Miscellaneous budget to pay for this work.
- 9.3 Cllr Grimson asked whether there were any volunteers available to attend the Town & Parish Planning Liaison meeting on 29 March 2011. Cllr Bray indicated that she will try to attend.

## **9.4** Hatch Farm Dairies:

Cllr Grimson indicated that the Planning Committee had discussed the application and reported on the Committee's objections to the Council. The agenda for the Public Meeting on Friday 11 March was distributed to councillors. At the meeting Cllr Grimson proposes to give a guideline to addressing planning concerns. He will focus on the principles of development, including flooding and access.

#### 10 LAST R&A COMMITTEE MEETING

- 10.1 The minutes of the meeting of 1 March 2011 were agreed, and the Parish Council **RESOLVED** to sign them as a true record.
- 10.2 Cllr Plant reported that the laying of the new floor had been completed. She reported that the press had been invited to the meeting of Winnersh Ballroom last week and that the Council was supplying photographs and a press release.
- 10.3 Cllr Plant explained the damage caused by dirt to the surface of the floor and the necessity for keeping as much dirt as possible off the floor. The Council RESOLVED to authorise the purchase of a multi-purpose floor cleaning machine and an exterior high-pressure cleaner, to be funded from the Hall Floor Refurbishment budget.

## 11 HALL FLOOR

- 11.1 The Clerk reported on the process of replacing the hall floor, including the works undertaken to the base beneath the floor itself and the incidental works to matting and doors.
- 11.2 The Clerk gave a breakdown of the costs of the works involved and the Parish Council **RESOLVED** to approve the payment of the final invoices related to the laying of the hall floor.
- 11.3 Cllr Jupp **PROPOSED** and Cllr Armstrong **SECONDED** and the Parish Council **RESOLVED** a vote of thanks to the chairman and members of the R&A Committee and to the Clerk and FAO for bringing the project in on time and to budget.

## 12 REPRESENTATIVES ON OUTSIDE BODIES

12.1 Cllr Grimson reported on a meeting of the BALC Executive Committee and the service level agreement made between BALC and CCB. He reported the HMRC decision that parish clerks can no longer be self-employed.

#### 13 APPROVAL OF ACCOUNTS

13.1 The Council decided that, for practical reasons, the inclusion of Cllr Lainsbury on the bank mandate should be deferred until the May 2011 meeting when changes to the mandate will be made en bloc following the local elections.

13.2 It was **PROPOSED** by Cllr Plant and **SECONDED** by Cllr Southgate and the Parish Council **RESOLVED** to pay the following accounts for March 2011.
