MINUTES OF THE MEETING OF WINNERSH PARISH COUNCIL HELD AT 7.45 p.m. ON TUESDAY 11 OCTOBER 2011 IN THE JOHN GROBLER ROOM

- 1 APOLOGIES
- **1.1 Apologies for absence** Cllrs F Breedlove, D Green, L Lainsbury, E Siggery.
- **1.2** Apologies for lateness none
- 2 MINUTES OF THE PREVIOUS MEETING
- 2.1 The minutes of the Council meeting of 13 September 2011 were agreed, and the Parish Council **RESOLVED** to sign the minutes as a true record.
- 3 MATTERS ARISING
- **3.1** None.
- 4 PUBLIC SESSION
- **4.1** There were no issues raised by the public.
- 4.2 Mr Peter Baveystock of Wokingham Borough Council gave a talk on the proposals for the collection and recycling of waste to be implemented from April 2012. The proposals cover three areas:
 1. collection of residual waste

- 2. recycling (ie paper/card, plastic bottles, food/drink cans, aerosols)
- 3. garden waste chargeable service

Mr Baveystock indicated that the collection of residual waste would be limited to a specified number of official bags. There would be an incentive scheme to encourage recycling. He also outlined the charges per bin or per bag for green waste.

Mr Baveystock answered councillors' questions on the recycling of glass and food waste, and discussed WBC's approach to fly tipping. Cllr Southgate thanked Mr Baveystock for his informative talk.

Mr Baveystock left the meeting.

7 BOROUGH COUNCIL MATTERS

7.1 Cllr Bray reported:

- 1) on the recent news of the recycling incentive scheme. She also explained the principle of the government grant for weekly waste collection
- 2) the Hatch Farm Dairies application, in its form from early 2011, is being considered by the next WBC Planning Committee meeting. Cllrs Bray and Grimson will present the Parish Council's views

- 3) there is no progress yet on finding a replacement WBC CEO
- 4) the SDL Masterplans have been adopted
- 5) an additional sum of money has been allocated by WBC to cover judicial reviews
- 6) a discussion took place regarding the implications of the approval of a free school at Ryeish Green and a technical college in Reading.

8 PARISH COUNCILLORS' QUESTIONS

- **8.1** The Council discussed possible roadworks at the crossroads. Cllr Bray had no additional information.
- **8.2** There were no questions on Parish matters.

9 LAST PLANNING COMMITTEE MEETING

9.1 The minutes of the meeting of 12 September 2011 were agreed, and the Parish Council **RESOLVED** to sign them as a true record.

The minutes of the meeting of 3 October 2011 were agreed, and the Parish Council **RESOLVED** to sign them as a true record.

Cllr Grimson reported that photo-voltaic cells had been approved for the Wokingham Cricket Club and on an office roof at Winnersh Triangle.

10 LAST R&A COMMITTEE MEETING

- 10.1 The minutes of the meeting of 4 October 2011 were agreed, and the Parish Council **RESOLVED** to sign them as a true record.
- 10.2 Cllr Plant reported that the Committee had discussed the provision of skateboard facilities, as requested by Full Council. She reported that this seemed impractical on the grounds of insurance, maintenance and location. The Committee RECOMMENDED that the proposer of this project produces information regarding costs, size of the facility and emergency access. Cllr Bray will take this request back to the proposer of the project.

- 10.3 Cllr Plant reported that the Committee had discussed the provision of nappy changing facilities in the Pavilion, as requested by Full Council. The Committee considered the provision of such facilities to be impractical. The Committee RECOMMENDED that the provision of nappy changing facilities be included in the specification for the external toilet, which is under consideration.
- 10.4 Cllr Plant reported on the proposals for the Christmas Lights event.

11 NEXT FINANCE & GENERAL PURPOSES COMMITTEE MEETING

11.1 The next meeting of the F&GP Committee was postponed until Tuesday 29 November 2011.

12 STAFFING UPDATE

12.1 The Clerk and Cllr Southgate updated the meeting with information regarding recent staffing recruitment.

Chris Fazey is settling in as caretaker and a letter of commendation regarding the cleanliness of the Recreation Ground has been received. June Mullar has started as Relief Caretaker, covering Mondays and the caretaker's holidays.

Amanda Lambourne has been appointed from a large number of quality applicants as FAO. In consideration of Miss Lambourne's previous financial experience the Council **RESOLVED** to make her the Responsible Finance Officer (RFO).

12.2 The Parish Council **RESOLVED** to appoint Miss Lambourne as a signatory to the Nat West bank accounts, for administrative purposes only.
