11 WPC BROADBAND SERVICE

11.1 The Clerk and Cllr Green reported on the developments relating to the problems with the Council broadband service. Investigations have been made into the costs and practicalities of alternative broadband supplies. The Council **RESOLVED** to authorise the cancellation of the TalkTalk account and the changeover of supplier to Plusnet, at a date to be decided.

12 WPC CO-OPTION PROCEDURE

12.1 Cllr Green reported that the Council is now three members short of its full complement of councillors. He asked councillors to encourage residents to apply for co-option. The Clerk and Cllr Green are making investigations and will draft a formal co-option procedure for the Council which will be reviewed by the next F&GP Committee meeting, before being presented to the Full Council for adoption.

13 BOROUGH/PARISH CONFERENCE

13.1 Cllr Grimson reported on the Borough/Parish Conference. He observed that the breakout sessions were well received and there seemed to be more desire to improve communications between the Borough and Towns & Parishes.

Cllr Green reported that most towns and parishes have websites and newsletters.

The Council discussed WBC's request for information regarding events related to the Olympics 2012 and the Queen's Jubilee. The Council approved in principle that the Fete 2012 should have a Jubilee theme. (see also N7 of Correspondence)

14 REPRESENTATIVES ON OUTSIDE BODIES

- 14.1 Cllr Cooke had attended an RE3 meeting. Currently about 80% of waste is being recycled or re-used. The contract for the new waste collection service will go live from April 2012.
- 14.2 Cllr Cooke reported on preparations for the TV digital switchover in February 2012.
- **14.3** Cllr Grimson has been appointed vice-chairman of WDALC.
- 14.4 Cllr Grimson reported on the BALC AGM. A large amount of information is being fed down from Central Government and is being filtered and summarised by BALC.

He reported on the latest news of the Localism Bill.
