1 APOLOGIES

- 2 MINUTES OF THE PREVIOUS MEETING
- 2.1 The minutes of the Council meeting of 8 November 2011 were agreed, and the Parish Council **RESOLVED** to sign the minutes as a true record.

- 4.1 Mr Tilbe spoke about the leaking taps at the allotments. Cllr Green confirmed that the water will be turned off and all the taps replaced over the winter.
