1 APOLOGIES

2.1 The minutes of the Council meeting of 13 March 2012 were agreed, and the Parish Council **RESOLVED** to sign the minutes as a true record.

4 PUBLIC SESSION

4.1 Cllr Green introduced Inspector Mike Graham of Thames Valley Police. Inspector Graham reported that in the 12 months since he had last spoken to the Council crime had continued on a downward spiral and that the police were dealing with the public's perception of crime. He asked that the public continues to report crime and ASB so that resources can be best targeted. PC Ali Marman has moved on and a replacement is being recruited. The neighbourhood teams are being streamlined. Sarah Hill is now the Neighbourhood Administrator. The Council will invite the new neighbourhood PC to attend a council meeting, when in post.ACTION: Clerk The Council asked about the recent fatality at the crossroads. At the end of the investigation a report will be issued. The Council asked the Clerk to enquire of WBC Highways how long it will be before the barriers at the crossroads are removed. **ACTION: Clerk** Cllr Green thanked Inspector Graham.

Cllr Grimson reported on comments regarding the poor visibility of the pedestrian crossing on King Street Lane, particularly in daylight. The Clerk was asked to forward these concerns to the WBC Highways department. ACTION: Clerk

10 LAST R&A COMMITTEE MEETING

- **10.1** The minutes of the meeting of 3 April 2012 were agreed, and the Parish Council **RESOLVED** to sign them as a true record.
- **10.2** Cllr Plant reported that repairs to the playground roundabout and gates were complete. The siting of the external toilet in the pavilion had been discussed and the garage was now considered to be the best site for the toilet. The Clerk is getting quotes from contractors.
- 10.3 Cllr Plant reported on the supplementary invoicing subsequent to a January hiring. £100 payment had been received. The R&A Committee had RECOMMENDED and the Council RESOLVED to write-off the remaining £68 of the invoice.
- 10.4 The date of the June 2012 R&A Committee meeting was discussed. The provisional date clashes with the Jubilee celebrations. Thursday 31 May 2012 was considered as a suitable alternative. The Clerk will contact absent members to see whether they are available on the day. ACTION: Clerk

12 CIVIC AWARDS 2012

12.1 The Council considered the timing of the Civic Awards for 2012. It was agreed that the presentation would take place at the Fete on 16 June 2012. The closing date for nominations will be noon on 30 May 2012. The winner(s) will be selected by the Executive Committee.

13.1 Cllr Southgate reported on the progress of the fete. Segway, one of the major arena events, has withdrawn. Alternative options for the supply of the PA system were discussed. Cllr Southgate was asked to contact an alternative supplier.

14 REPRESENTATIVES ON OUTSIDE BODIES

- **14.1** Cllr Cooke had attended an RE3 meeting. He reported on the volumes of waste passing through Smallmead. He confirmed that many staff had been re-employed by Veolia for waste collection, but that they were not necessarily employed on the same routes.
- **14.2** The Clerk reported on the demise of the Standards Board. WBC was expected to make an announcement on the new monitoring arrangements in July 2012.
- 14.3 Cllr Southgate reported on the NAG AGM. Pat Rowell remains the Chairman and Frank Breedlove the Treasurer.It was now dealing with fewer issues. It had discussed the crossroads signage and timing of the traffic lights and reported on the police reorganisation.
- **14.4** 14 April 2012 was reported as the date for the first match at Wokingham Cricket Club's new ground.
- **14.5** Cllr Plant updated the meeting on the Neighbourhood Watch scheme and the replacement of Ringmaster by the new Thames Valley Alert.

15 APPROVAL OF ACCOUNTS

- **15.1** The Council discussed the WPC provision of street lighting within Winnersh.
- **15.2** The Clerk reported on the change in requirements by the PRS and the consequent increase in charges.
- **15.3** The Clerk confirmed that the first of the 2012-13 R&A projects, the refurbishment of the Main Hall chairs, was completed to budget.
- **15.4** The Clerk confirmed that a batch of stamps was being purchased before the increase in stamp prices.
- **15.5** The Clerk summarised the purchases made on the credit card. The Council asked that the details be included on the summary report in future. **ACTION: FAO**
- **15.6** The Clerk confirmed that the change of signatory documents had all been handed in to Nat West bank. He is awaiting notification from Nat West of the completion of the changes.
