4.1 Cllr Green welcomed PC Tin Wong and PCSO Mike Neave of TV Police. PC Wong gave an update of crime in Winnersh and adjoining areas. He reported that two new PCSOs are undertaking training and will become active before the end of the year. He reported on other staff turnover. Discussions took place relating to the reporting of incidents and the use of the 101 telephone number and the use of the Commercial Security Advisor.
