- 11.3 The F&GP Committee **RECOMMENDED** and the Council **RESOLVED** to award a grant of £850 to Keep Mobile.

- 12.1 Cllr Southgate reported on the Borough / Prish Conference and the devolution of services. The Council discussed briefly the implications of S106, CIL, WPC staffing and budgets, on the choices of services to be accepted from WBC.
- 12.2 Cllr Southgate reported on the meeting with the WBC Highways department to discuss traffic modelling. He indicated that the acceptance of Option B for the N Wokingham Relief Road would potentially increase the traffic flow through Winnersh Crossroads by 25%. The Council will continue to press for the early completion of the Winnersh Relief Road. The Council noted the potential upgrade of Lower Earley Way between the Relief Road and Loddon Bridge roundabout.
 - The Council discussed the effect of Option B upon the Reading Road allotments.
- 12.3 Cllr Cooke reported on the Re3 stakeholders meeting and the limitations of the kerbside recycling provision.

The Council discussed the use of recycling points and the opportunity to transfer points to local schools. Cllr Cooke will discuss this with Bearwood Primary School.

APPENDIX 2

Note by Councillor Philip Houldsworth to the Council Meeting of Winnersh Parish Council Tuesday 11th November 2013

I regret I cannot attend tonight's meeting but I attach my comments on the month.

Borough Matters

Good news on Planning. Although the MDD is not yet finally approved, its preliminary findings are carrying more and more weight. Recent appeals against planning decisions have failed especially on the 5 year supply of housing argument.

As you know the Taylor Wimpey application for the land east of Wigmore Lane was refused.

There is a proposal for a care home in the close area but this doesn't seem to meet social services present thinking on the care of the elderly so we await the outcome on this.

My work on Affordable Housing continues and we are achieving provision in line with our policy. If I don't think that a site is appropriate then we seek a commuted sum which can be used for social housing elsewhere. This week alone commuted sums of £6.39m were agreed.

There are applications for back garden developments in Winnersh of which you are aware. Planning have refused permission of others not in Winnersh and I would expect the same of the Arbor Lane and Wigmore Lane proposals.

Philip Mirfin will be replacing Alistair Corrie in May as the lead member on the Wokingham Town Centre refurbishment and there will be a debate about Elms Field on Wednesday 4th December following a petition. I would expect the Council to vote in favour of continuing with the published plans but we will see.

The Borough/Parish Conference took place on the 6^{th} November and I think that delegates found it useful.

Items for the next Council meeting include the recommendation on the most Appropriate Decision Making Governance for Wokingham.
