APPENDIX 2

Report to Winnersh Parish Council

A fairly quiet time since the December Parish Council. There is an additional Council Meeting called by the Lib Dems being held on the 16th January which I am not attending as I am away. It is to discuss the motions that they put forward in December but were not heard due to a lack of time.

There is a fairly busy Executive meeting at the end of January which includes the A329 cycleway Phase 3. I know that many here are very concerned with the proposed arrangements. I have forewarned John Kaiser that unless the plans are amended I will request the withdrawal of the plan until we have a satisfactory arrangement.

Budgets are being finalised for next year and it does look at this time that we will have a nil increase but there is more to do and we do not know whether there will be additional funding on offer to avoid increases.

I attended a meeting of the Country Parks Working Party to discuss the consultation paper for Dinton and what options there were for the use of the old golf course. Earlier I had researched the footgolf option by visiting the websites of every footgolf course in the South East. I found that there were no standalone footgolf courses, all were part of larger golf clubs who had 18 hole courses and 9 hole courses. In some cases the 9 hole courses had been closed and transformed into 18 hole footgolf courses and in others a 9 hole footgolf was combined with the 9 hole golf course. Also it is an adult game with a defined dress code, there is a need to kick the ball a long way off the tee, so children would have to be fairly robust teenagers rather than 10 year olds. I have also suggested as an option, a city Farm. We will see what the consultation brings.

We will also consider options for California later in the year. But the overall approach is to try to make the Parks cover their costs given the ongoing budget pressure imposed on us by central government which can only increase.
