2 MINUTES OF THE PREVIOUS MEETING

2.1 The minutes of the Council meeting of 10 February 2015 were agreed, and the Parish Council **RESOLVED** to sign the minutes as a true record.

7 BOROUGH COUNCIL MATTERS

- 7.1 Cllr Southgate read Cllr R Shepherd-Dubey's report. See Appendix 2.
- 7.2 Cllr Houldsworth reported:
 - The implementation of the Care Act was leaving WBC with a £1.7m shortfall.
 - It is hoped that forward funding will help enable the building of the Relief Road before the builder's contributions are received.
 - Wokingham Town Centre regeneration: The Beech Place proposal has been approved. The consultation on the Elms Field proposal has begun.

7.3 Cllr Bray reported:

- Planning Permission is awaited for the Relief Road. The forward funding may be available from 2020.
- There had been a delay clearing debris after a traffic accident at the crossroads.
- Sainsburys is due to re-open tomorrow.
- There is the possibility of a disabled parking place at the site of the new post office.
- There is a 0% change in the WBC Council tax this year.
- Further details on the effects of the implementation of the Care Act.

Report from Cllr R Shepherd-DuBey

1. HATCH Farm

Developers are expecting to start building the road between King Street Lane and Lower Earley Way starting in September if they get final planning approval.

2. Winnersh crossroads

Once again WBC is going to try to realign the traffic signal timings for the crossroads sequences, hoping this time to fix the queues.

3. Showcase roundabout

Works seem to be going slowly as most projects do. Hopefully the sequencing of the signals will work better than the crossroads. They don't seem to be planning to change the amount of waiting for Winnersh residents going to A329M, even though I have asked them to work on it.

4. Bike Lanes seem to be going forward ignoring the requests for right turn lanes off the Reading Rd.
