# Report from Cllr R Shepherd-DuBey

1. Hatch Farm Dairies Residents group

I met with Winnersh residents concerned about Hatch Farm Dairies and the Developers of the site. There was still some confusion about when the application was approved. The outline planning application was approved by the planning committee in 2011. The developers signed their Section 106 agreement a few months ago. The residents thought that was the final reserved matters application. They do have approval to start building the intersections on King Street Lane and the one on Lower Earley Way. This is something called a section 278\_where the developer builds roadworks at a less expensive cost to WBC than it would if WBC built the junctions. They would like to start working on these intersections in September, they will still have to talk with WBC to set a date for the construction.

There will be future meetings dealing with flooding.

- 2. Bike paths phase 3 in Winnersh from the Crossroads to Simons Lane is penciled to start construction in October or November 2015. I have asked for a consultation with the parish council before they begin construction. Hopefully we can get some input into the design earlier this time. They were not aware that the proposed Winnersh Bypass is in the middle of this proposal.
- 3. The latest software change on the crossroads seems to have slowed traffic on King Street Lane and Robin Hood Lane with no appreciable difference to the Reading Road either from Wokingham or The Showcase roundabout. They may tweak the software again but the crossroads is operating above its capacity and nothing will help except for the proposed Bypass. The Northern Distribution Road looks like it will be coming forward subject to ecological surveys of the land, the actual route is still to be determined.

I am still trying to make sure that it goes along next to the M4 to cause the least disruption to the Allotments, the Millennium Arboretum and the Winnersh Fuel Allotment Trust. I am still pursuing WBC to guarantee us access to the field next to the allotments to move the effected allotments.

# Note by Councillor Philip Houldsworth to the Council Meeting of Winnersh Parish Council

# Tuesday 14<sup>th</sup> April 2015

I regret I cannot attend tonight's meeting but I attach my comments on the month.

I am grateful to Mr Hanna for asking questions at Council about the **Winnersh Relief Road**, which I hope have clarified the position. It is fully funded and as soon as Bovis is on site it will be built. I know that John Kaiser has instructed the Officers to work on the preliminary designs.

My work on Affordable Housing continues and we are achieving provision in line with our policy. If I don't think that a site is appropriate then we seek a commuted sum which can be used for social housing elsewhere. The amount raised in Commuted Sums now stands at £31m and we have a further £72m under negotiation. We have now set up a Commuted Sums Panel to receive applications for the use of this money. It will be an open Panel with cross party membership including a representative from the Tenants. It is very important that this operates entirely in the open.

As you can see our work on Decent Homes continues with the roofing of the Courts. This is funded by Government by the work has to be completed to a very tight schedule.

Option B has been confirmed for the Arborfield Relief Road and there is to be a briefing this week on the Northern Distributor Road for Winnersh Councillors

The Care Act is now in force which combines NHS and Social Services as far as the care of the elderly and vulnerable are concerned. It is very early to say how this will all work out and WBC together with West Berkshire is taking legal action to try to get the proper funding for the service.

Not quite Winnersh but the proposals for Elms Field are out to consultation.
