## 2 <u>SCHEDULE OF APPLICATIONS</u>

- 2.1 The following applications were examined and NO OBJECTIONS were recorded:
- 1F/2009/055218 Kelburne CloseA Smithproposed erection of a single storey side extension to form conservatory.
- 2 F/2009/0578 11 Jersey Drive A Smith proposed erection of a single storey rear extension and a side entrance with a new porch to replace existing front entrance

#### **2.2** Applications subject to OBJECTIONS:

1 F/2009/0265 564 Reading Road A Smith proposed change of use from Office (B1a) to Residential (C3) plus raising of roof to create first floor accommodation

The Committee **objected** to this application on the following grounds:

- 1) it is clearly intended to be a separate dwelling to the rest of 564 Reading Road, and as such it is tandem development within 8metres of the adjacent building
- 2) it is out of character with the open plan nature of Greenacres Avenue
- 3) it is in front of the building line on Greenacres Avenue
- 4) there is poor visibility for cars moving onto Greenacres Avenue from the proposed driveway

2 F/2009/0506 7 St Marys Road

J Bishop proposed erection of 3 bedroom attached dwelling, existing access to be used, plus demolition of existing garage and carport

The Committee upheld its previous **objections** to this application:

- it is out of keeping with the surrounding area 1)
- 2) it would cause overdevelopment of the area
- 3) the side wall would loom over neighbouring properties
