## 2 <u>SCHEDULE OF APPLICATIONS</u>

# 2.1 The following applications were examined and NO OBJECTIONS were recorded:

- 1 A/2009/1785 Junction of Eskdale and Wharfedale Road M Turner application for advertisement consent for a temporary main contractors sign board
- 2 F/2009/1787 Windrush Court, Old Forest Road D Wetheril proposed erection of single storey rear extensions to form conservatories on plots 2, 3, 4, 33 & 34. (Amendment to consent F/2007/1160 for the erection of 34 dwellings).
- 3 F/2009/1851 National Grid plc, St Catherines Lodge, Bearwood Road N Clark proposed installation of 2 No above ground diesel tanks and 2 No new generators. (Removal of of 2 No below ground diesel tanks. Provision of ARMCO barriers to separate protect the fuel tanks and generators from site traffic.
- 4 F/2009/1876 498, Unit 1, Reading Road N Clark proposed installation of two new external windows to side elevation, plus erection of an additional air conditioning condenser, and relocating of existing condenser.

Although not objecting to this application the Committee **commented** that the new windows will overlook adjoining properties in Reading Road and Chatsworth Avenue and should be made of obscured glass.

#### 2.2 Applications subject to OBJECTIONS:

1 F/2009/1768 487 Reading Road H Wilson part change of use from A1 to A5 use (hot food take-away). Alteration to existing store front and residential porch to allow 2 customer and 3 staff parking spaces. Provision of separate front door access to new hot food takeaway outlet.

The Committee **objected** to this application on the following grounds: The Committee does not believe parking will be adequate for a hot-food outlet. The turning spaces will be used for additional parking leading to vehicles reversing out onto a main road in the vicinity of a road junction and traffic island.
