2.2 Applications subject to OBJECTIONS:

- Cramped and detrimental to the character of the area
- Insufficient amenity space for future residents
- Inadequate parking spaces
- F/2014/2611 Land between Grovelands Avenue Caravan Park and Grovelands Avenue Workshops, Grovelands Park, Winnersh RG41 5LD N Chancellor Proposed erection of residential development of 6no two bed dwellings with associated external works.

The Committee **OBJECTED** to this application on the following grounds:

- The development is overbearing
- The development is out of character with neighbouring properties
- This is overdevelopment of the site.
