Minutes of the PLANNING COMMITTEE meeting held in the ALLNATT PAVILION on MONDAY 10 JUNE 2019

- 1. Apologies for absence were received from Cllrs C Taylor, F Obileye, B Krauze.
- 2. Declarations of Interest: None.

- 4. Public session: there were two members of the public present. There were no questions or comments.
- 5. The committee considered the following applications and raised no objections:-
- 5.1 Application Number 191172: Observations by 11/06/2019

Site Address: 7 Russell Way, Winnersh, RG41 5SN

Proposal: Erection of a part single, part two storey front extension, first floor side extension, new pitched roof to existing single storey rear extension, insertion of 6no. roof lights, installation of 12no. PV solar panels over rear slope of main roof, internal alterations and changes to fenestration.

5.2 Application Number 190806: Observations by 11/06/2019

Site Address: 3 Arbor Meadows, Winnersh, RG41 5ED

Proposal: Erection of a single storey rear and first floor side extensions to dwelling.

5.3 Application Number 191183: Observations by 11/06/2019

Site Address: 4 Annesley Gardens, Winnersh, RG41 5PB

Proposal: Conversion of existing garage into habitable accommodation with insertion of two roof lights, plus erection of rear conservatory extension.

Proposal: Erection of a single storey side extension.
