Site Address: Windsor Cottage, Merryhill Green Lane, Winnersh, RG41 5JP **Proposal:** Householder application for the proposed single storey extensions to front/side following the removal of existing carport plus porch extension to front following the replacement of existing porch canopy plus to side following the demolition of detached existing garage to rear/side following the removal of existing conservatory and insertion of 7no. rooflights and internal alterations to existing dwelling.
