2 CLERK'S REPORT

CLERK'S REPORT as at 2.1.13

Update on items since the meeting of 4.12.12

Play Area/Recreation Ground

The old play area has been flooded for several weeks. The Kompan Elements edge unit has been closed and fenced in. Assessment of repairs has not been possible whilst the area was flooded. The corner of the small 11 a side pitch has also been flooded for several weeks. Rhododendrons overhanging New Road have been cut back.

There have been signs of further drug use at the top of the field. Thieves were disturbed whilst trying to remove a wooden gate from the Community Centre. The Clerk will report these incidents to the police.

A vehicle reversed into the fence to the caretaker's garden and has damaged a post and panel.

Pavilion

We are awaiting details of the shower head/thermostat replacement. The gas meter to the Pavilion has been replaced.

The Clerk confirmed that WRFC will pay for a sign at the entrance to the car park.

9.2 S106 projects for 2012-13

The Clerk has contacted WBC regarding the suitability of the external table tennis table for S106 funding. A reply is awaited.

- 9.4 Kompan Elements matting repairs: The Clerk reported that he has liaised with the WBC Parks & Leisure officer who has been joined by an independent expert. They have lifted the existing matting to investigate the sub-base to the matting. A report and quotation for repairs will be sent in to WPC. The equipment is out of order and fenced off until permanent repairs can be made.
