CLERK'S REPORT as at 5.3.13

Update on items since the meeting of 5.2.13

Play Area/Recreation Ground

The old play area is drying out. The Kompan Elements edge unit remains closed and fenced in. The order for replacement matting has been placed. At WRFC's request Nick Robins has checked the dimensions of the line markings for the adult football pitch. WRFC have queried the duplication and quality of line markings.

Pavilion

A detailed quotation is awaited for the completion of plumbing/ heating works to the Pavilion.

Pavilion House

Main Hall/Offices

The electricians are due to complete the repairs to the external security lighting system soon. A detailed quotation has been received and the Committee confirmed that this work could go ahead. A revised quotation is awaited for repairs to the high level internal and external lights at the Community Centre.

PAT testing is being arranged for the Community Centre electrical items.

The servicing of the Main Hall boilers is awaited. The Clerk will make a preliminary investigation into finding an alternative contractor.

The order for the replacement matting has been placed. This requires dry weather before the work can go ahead. The contractors will do an investigatory dig next week to see whether the ground is dry enough for the work to begin.

11.5 Community Centre Drains clearage:

The Clerk reported that the drains at the entrance to the car park had been cleared of roots and mud.

The Clerk presented the quotations for the clearing of the three series' of drains to the play areas and field (item N2 of Correspondence). The Committee **RESOLVED** to accept the quote, with the priority for the work to be the children's play area drainage.
